



Bookstore Policies & Frequently Asked Questions

How will I know my order has been processed?

You will receive an e-mail confirming your order. Please be sure to include a correct e-mail address, or you will not receive a confirmation.

How do I place an expedited order?

You must place your expedited order by 1 p.m. ET for it to be shipped that day. To place an expedited order, you must fax a completed [publications order form](#) to 703.516.9308. You may also place your order online through the [ASPPA Bookstore](#). Orders received after 1 p.m. ET will be shipped the following day via 2nd day delivery.

How do you calculate the shipping cost for publications other than The ERISA Outline Book?

Please Note: do not include shipping charges for any downloadable PDF product purchased. PDF products are delivered to your ASPPA account immediately, therefore there is no shipping charges. **PDFS CANNOT be returned when purchased because access is provided immediately.**

What are the shipping costs for *The ERISA Outline Book*?

Shipping prices apply to each set of The ERISA Outline Books purchased.

Example: Shipping and handling for 2 sets of The ERISA Outline Book shipped regular ground would cost \$70.00.

Is international shipping available?

International shipping is available by faxing a completed [publications order form](#) to 703.516.9308 or placing your order online through the [ASPPA Bookstore](#). Delivery time will depend on country of destination and courier service. Shipping fee will be 20% of the order total.

What is the shipping time on my order?

| Shipping Option | Shipping Time |
|------------------------------|---|
| Ground | Approximately 10-14 days |
| Ground Rush | Approximately 5-7 days |
| Air Rush 2 nd Day | 2 days (order must be placed by 1 pm ET) |
| Overnight | Next day (order must be placed by 1 pm ET) |

What happens if an item is out of stock?

You will not be charged for an item until it is in stock. As soon as the item becomes available, it will be shipped via the shipping method you chose when you placed your order.

What is the return policy?

Most items (see below for exceptions) may be returned for a refund minus a 10% restocking/order cancellation fee within 30 days of purchase provided the condition is unused. Refunds are issued only upon receipt of items in the ASPPA Book Department and after the condition of items have been confirmed. Shipping costs are not refunded.

Which items cannot be returned?

Returns are not accepted for any electronic documents, including all PDF documents and the Online Version of *The ERISA Outline Book*.

How can I return an item?

How do I place my order?

There are 3 ways to order publications:

1. **Online:** You can order online at the ASPPA Bookstore at www.asppa.org/bookstore.
2. **Mail:** You can mail the publication order form, with payment, to: ASPPA-Publications, P.O. Box 34725, Alexandria, VA 22334-0725.
3. **Fax:** You can fax in the [publications order form](#) to ASPPA at 703.516.9308. Important: fax **all** pages of the form. **Credit card information must be included.**

How do I access an electronic publication or PDF document once I order it?

To access electronic publications, visit www.asppa.org/access-electronic-publications. You must have an ASPPA account to access and download your documents. Once you are in your account, you will see a list of all of your available downloads.

When will I receive access to the online edition of The ERISA Outline Book?

Online Edition purchasers of The ERISA Outline Book will receive log-in information via e-mail within 3-5 business days after purchase.

Does ASPPA offer discounts on publications?

A 10% discount off the member pricing* is available on orders of 10-19 copies of the same publication shipped and billed to a single contact. A 20% discount off the member pricing* is available on orders of 20 or more copies of the same publication shipped and billed to a single contact.

*Discounts do not apply if orders occur separately; if ordering in bulk, the ASPPA member pricing applies. Discounts do NOT apply to *The ERISA Outline Book*, RPF Courses (PDF format only) or practice examinations. To receive the discount, please contact ASPPA Customer Support at 703.516.9300 between 8:30 a.m. and 5:30 p.m. Eastern time. Discounts are not available on orders placed online.
